

## THE 2018 e-VIC AMELIA ISLAND DREAM VACATION SWEEPSTAKES

### OFFICIAL RULES

**e-VIC/VIC Card Sign-Up.** Any time between January 1 and March 31, 2018, you will be entered when you visit [www.harristeeter.com](http://www.harristeeter.com) and click on the e-VIC button or page and follow the steps to join Harris Teeter's e-VIC program.
