

**2017 e-VIC GREAT AMERICAN BASEBALL GIVEAWAY

**e-VIC/VIC Card Sign-Up.** Any time between April 1<sup>st</sup> and June 30, 2017, you will be entered when you visit [www.harristeeter.com](http://www.harristeeter.com) and click on the e-VIC button or page and follow the steps to join Harris Teeter's e-VIC program.
