

THE 2018 e-VIC AMELIA ISLAND DREAM VACATION SWEEPSTAKES

OFFICIAL RULES

e-VIC/VIC Card Sign-Up. Any time between January 1 and March 31, 2018, you will be entered when you visit www.harristeeter.com and click on the e-VIC button or page and follow the steps to join Harris Teeter's e-VIC program.
