

2020 e-VIC DISCOVERY COVE SWEEPSTAKES

OFFICIAL RULES

e-VIC/VIC Card Sign-Up. Any time between January 1 and February 29, 2020, you will be entered when you visit www.harristeeter.com and click on the e-VIC button or page and follow the steps to join Harris Teeter's e-VIC program.
